This includes Auto Commodities (Pty) Ltd, Auto Commodities Northern Cape (Pty) Ltd and Phodilogistics (Pty) Ltd, a Level One BBBEE fuel wholesaler, importer & exporter. The majority of fuel distribution and collections are enhanced by supplying product from our own operated storage depots and terminals, resulting in a timeous and customized service to our clients.

Our Transport, Logistics and Warehousing division provides various unique solutions to a vast variety of customers.
